PRIVACY POLICY

1. Introduction

Welcome to The Corner Butcher. We are committed to protecting your privacy and ensuring your personal information is handled in a safe and responsible manner. This Privacy Policy outlines how we collect, use, disclose, and protect your personal information in compliance with the Privacy Act 1988 (Cth) and other relevant privacy laws in both Western Australia and Commonwealth legislation.

For the purposes of carrying out our business activities, The Corner Butcher ABN 86 549 928 171, **(we, us, our)** will collect, hold, store and disclose your personal information. Personal information is information or an opinion about an identified or reasonably identifiable individual, whether or not the information or opinion is true and whether or not the information is recorded in a material form.

2. Information We Collect

Some information provided to us by clients, customers, contractors and other third parties might be considered private or personal. Without these details we would not be able to carry on our business and provide our services to you. We will only collect such personal information if it is necessary for one of our functions or activities.

We may collect the following types of personal information:

- Contact Information: Name, phone number, email address, and postal address.
- **Transaction Information:** Details of products or services purchased, transaction amounts, and payment information.
- **Usage Data:** Information about how you interact with our website or services, including IP addresses, browsing history, and other technical data.
- Marketing Preferences: Your preferences for receiving marketing communications from us.

3. How We Collect Your Information

We collect your personal information in the following ways:

- Business Transfers: In connection with a merger, acquisition, or sale of all or a portion of our business.

6. Data Security

We take reasonable steps to protect your personal information from unauthorized access, use, or disclosure. This includes implementing physical, electronic, and managerial safeguards. However, please be aware that no security measures are completely foolproof, and we cannot guarantee the security of your information.

7. Your Rights and Choices

You have the following rights regarding your personal information:

- Access and Correction: You can request access to or correction of your personal information that we hold about you, provided your request aligns with the National Privacy Principles.
